PRIVACY POLICY

K & H Medical Ltd is committed to ensuring that your privacy is protected. We will always ensure your data is kept securely and not disclosed to an unauthorised person. Should we ask you to provide certain information by which you can be identified when using our services, then you can be assured that it will only be used in accordance with this privacy statement and in compliance with the EU General Data Protection Regulation GDPR and the Data Protection Act 2018.

Collection of Data

In order to provide our services, we have collected and processed the following information:

- Your name, company name, and job title.
- Your contact information including address, phone number, and email.

Use of personal data

- If you are a customer at present we may use your personal data to improve the products and services we currently provide you or;
- If you are a former customer, we may use your personal data to improve the products and services we have delivered to you and conform to good business practices or;

Sharing your personal data

Retention of your personal data

- We will keep your personal data for as long as you remain a customer of the company plus 3 years. After this period, we will securely delete and destroy your personal data.
- Some data, however, must be retained in order to protect the company's interests, preserve evidence, and conform to good business practices.
- · Note that the need to retain certain information can be mandated by local, industry regulations and will comply with EU General Data Protection Regulation GDPR and the Data Protection Act 2018. Where this policy differs from applicable regulations, the policy specified in the regulations will apply.

Data Security

We take the security of all the data we hold very seriously and have security measures in place to protect it. We have a framework of policies, procedures and training in place covering data protection, confidentiality and security and regularly review the measures we have in place to keep the data we hold secure.

Individuals Rights as a Data Subject
